

# Notice of Intent to Award (NOIA)

## Call For Trainer and Facilitator Proposals (CFTFP) #CFTFP.2023.2024-0004

The Early Learning Coalition of the Big Bend Region, Inc. (ELC) released a publicly noticed Request for Proposals (“RFP”), Call For Trainer and Facilitator Proposals (CFTFP) #CFTFP.2023.2024-0004, on May 10, 2024.

ELC designated a three-member evaluation team (Eval Team) to review Proposals from sixteen Respondents using the same evaluation criteria (scoring rubric). **Respondents with shaded rows will receive Notice of Intent to Award (NOIA) notifications.** Should a Vendor decline its NOIA, ELC reserves the right to select the next highest ranked Proposal in the same or different Category.
