The Early Learning Coalition of the Big Bend Region, Inc. (ELC) publicly noticed the Request for Proposals ("RFP"), Information Technology, Network Administration, and Technical Support Services Request for Proposals (RFP), #RFP2023.2024-0003, in the Florida Administrative Register (FAR) and on its website on May 1, 2024, and e-mailed a solicitation notice to 415 Vendors including many with Certified Minority Business Enterprise (CMBE) as identified in MyFloridaMarketPlace (MFMP).

ELC received proposals by the 12 PM deadline on May 17, 2024, from three responsive vendors including Inspired Technologies, vTech Solutions, Inc., and Inteliblue, LLC, who have the qualifications, resources, and experience necessary to complete the work detailed in the Scope of Work (SOW) for this RFP.

ELC designated a three-member evaluation team (Eval Team) to use the same evaluation criteria (scoring rubric) to review/score all Proposals and timed presentations that followed the same question outline.

After the selected Respondent accepts their NOIA, ELC will coordinate with them to negotiate terms, conditions, and price to develop a Professional Service Agreement ("Agreement" or "Contract"). Should a Respondent decline its NOIA, ELC reserves the right to select the Proposal with next highest **Total Team Score** until one accepts the NOIA.

Term 1 will encompass a five-year period beginning on the contract execution date. The **Renewal Term** may equal the length of the original five-year term, or three one-year renewals, depending on negotiations. Any renewal is contingent on available funding and the Contractor's satisfactory performance. ELC anticipates that its Board of Directors will review/approve the Contract at its June 2024 Executive Committee Meeting and it will become effective on July 1, 2024, or after the last required party signs, whichever is later.

This NOIA does not constitute a binding commitment by ELC.
