



Attendance Reimbursement

Certified Contract Requirement

• You must have a certified contract with ELC to be reimbursed for VPK and/or School Readiness.

Attendance Submission Deadlines

- Submission Deadline: 3rd business day of the month
- Late Submissions: Will result in payment delays (paid the following month).
- Sign-in/Sign-out Sheets must be uploaded into the WebAuthor system under Provider Uploads.
- ALL Attendance Entry must be submitted in the Provider Portal (EFSMOD).

Helpful Tips

- Submit attendance early to avoid processing delays.
- Upload all Physician and "Mommy Notes" for absences.
- Remove terminated students from your roster.
- Use Provider Portal & WebAuthor to confirm submissions.
- Long Absences? Notify the Coalition if a child is absent for more than 5 consecutive days or 10 non-consecutive days without notice from the family.

Protective Services/Rilya Wilson Act Reporting

A provider must notify the ELC and Community Based Care (CBC) agency any time a protective services child is absent for **one day** without contact from the parent or caregiver by the end of the day and has **seven consecutive** unexcused absences.

Attendance Reporting Requirements

Providers must document daily attendance using signin/sign-out forms.

Forms must include:

- •Child's full name
- •Date
- •Time in & Time out
- •Parent/guardian signature

A Failure to maintain accurate records may result in payment delays. 🛆

Please Note: Payment dates are subject to change due to unforeseen circumstances, such as but not limited to natural disasters (e.g., hurricanes) or other events beyond our control.

Monitoring

All contracted providers must comply with School Readiness and VPK contract requirements.

Key Reminders:

- ELC staff must have access to the facility. If the director is unavailable, staff should know the location of the following required documents:
 - VPK Enrollment Certificates
 - Sample attendance records
 - Proof of copayments received
 - All contract-related records outlined in the monitoring email sent at the beginning of the monitoring program (note: this is different from program assessment emails, which are sent two weeks prior).

Failure to comply may result in placement on a corrective action plan or additional measures.

VPK Monitoring

Monitoring Period: Ongoing until early May 2025

Objective: Ensure compliance with VPK program requirements and support provider quality.

Key Monitoring Areas:

- Provider Program Information: Licensure, accreditation, and director credentials
- Classroom Compliance: Instructor qualifications, student ratios, and curriculum use
- Attendance and Progress Monitoring: Daily logs, monthly certifications, and screening compliance
- Insurance and Contract Compliance: Worker's compensation, general liability, and E-Verify affidavit

Next Steps:

- Ensure all required documents are up to date
- Request technical assistance if needed
- Compliance findings may require a corrective action plan (CAP)

Attendance Acknowledgement

Parents are required to complete the VPK attendance verification forms every month.

Use the **Short Form**

Parents sign in and out daily

Use the Long Form

Any method other than a daily sign-in form is used, such as a roll sheet or roster

School Readiness (SR) Monitoring

Monitoring Period: Ongoing until the end of May 2025

Objective: Assess compliance with School Readiness program standards and support provider adherence.

Key Monitoring Areas:

- Contract Execution & Readiness: EFS Mod profile, licensing, health & safety documents • Provider Compliance: Developmentally appropriate curriculum, child assessments,
- attendance certification
- Health & Safety Standards: Facility inspections, background screenings, emergency preparedness
- Financial Accountability: Parent copayment collection, reporting absences, maintaining records for audit

Next Steps:

- Providers should review and update all compliance documentation
- Any non-compliance issues will require follow-up and resolution
- Coalition staff are available for support and guidance

Contract Deadlines

Summer VPK Application Deadline: May 1, 2025 School Readiness Contract Deadline: May 20, 2025 VPK Application and Contract Deadline: July 31, 2025

Ensure all applications and contracts are submitted on time to avoid delays in processing.

Program Assessments

- Program Assessment registration must be updated in the Quality Performance System (QPS) for SR providers whenever staff changes occur.
- PLEASE DO NOT INCLUDE YOUR VPK CLASSROOMS in QPS.
- VPK providers with teacher changes must update their contracts in the Provider Portal.
- <u>Remember, Program Assessment is a contractual agreement</u>keeping your scheduled assessment is imperative. If an emergency arises, please contact resources@elcbigbend.org immediately so our team can assess whether rescheduling is necessary.

Program Assessments

- If you were assessed between August 2023 and March 2024, ELC is currently scheduling your 2024-2025 program assessments.
 SR providers will now receive a program assessment every year—
- SR providers will now receive a program assessment every year biennial status (every other year) no longer applies.
- ELC has partnered with the Children's Forum this year to complete program assessments. Please monitor your email for scheduling notifications, which may come from either ELC or the Children's Forum. The email subject line will be "Upcoming CLASS Observation."
 VPK program assessments will only be conducted during your.
- VPK program assessments will only be conducted during your contracted VPK instructional hours.
- Pre-K and Toddler program assessments will be conducted in the morning, while Infant program assessments may take place in the afternoon.
- Please share all program assessment resources with your staff in advance to ensure they know what to expect.

Ages and Stages (ASQ) Processing

- Screening is completed via EFS Mod when parents are coming into SR services
- Parents can defer a screening during the SR application process to the Provider or Coalition.
- The provider must use the provider portal to complete screenings that were deferred to them by the parent. We encourage you to check your Provider Portal account weekly - the system will not alert you.
- Screenings deferred to the Provider must be completed within the first 45 days from the child's enrollment date (NOT their start date, if different). The Provider Portal will provide you with the screening deadline for each child.
- Per your contract, Providers who do not meet this requirement will be placed on a Corrective Action Plan.

VPK FAST Assessment

VPK FAST Test Administrator Training

- If you hire new VPK teachers, they must complete the VPK FAST Test Administrator training before administering assessments to students.
- Proof of training (certificates and agreements) must be uploaded to the provider portal before PM2.

VPK FAST PM2 is HERE!

- Ensure that all VPK children are assessed by your PM2 deadline to remain compliant with program requirements. Deadlines vary based on each VPK schedule.
- Provide parents with a copy of the assessment results. This is both an important way to keep them informed about their child's progress and a VPK program requirement.

New Worlds Reading Initiative

Children who score below the 40th percentile on the FAST Star Early Literacy/Reading assessment are eligible to enroll in Florida's **free** home literacy program.

Program Benefits:

- One free book per month during the school year
- Resources & activities for caregivers and children to strengthen literacy skills

How to Enroll:

- We encourage all providers to inform families of eligible children and direct them to apply as soon as possible, as the verification process may take several weeks.





School Readiness Redetermination and Review Dates


Provider Profile Updates

To participate in Child Care Resource & Referral (CCR&R) services and maintain a School Readiness or VPK contract for the upcoming program year, **both contracted** and non-contracted Big Bend providers must update their profiles in the Provider **Portal and complete the Cost of Care** Survey.

Updating Your Provider Profile



The **General** Tab collects basic information about your program, including provider types and whether or not there is interest in contracting with ELC of the Big Bend to provide School Readiness or Voluntary Prekindergarten (VPK) services.

The Facility tab collects contact information for the provider. The Provider Portal user is required to enter contact information for staff responsible for different aspects of the business. If the staff person is an Authorized Contract Representative or VPK Authorized Contract Representative, click the checkbox below each section (Director, VPK Director, etc.).

The Services tab collects information on the ages of the children in your care, as well as different provider services.

The Curriculum tab collects information about your curriculum; you may choose multiple curriculums. If you are a School Readiness provider, an approved curriculum must be chosen. If no approved curriculum is being used, please select "Other." If you do not see your curriculum listed, choose "Other" as the curriculum.

Child Safety Seat Program

- Leon and Gadsden families currently receiving School Readiness or on the Waitlist are eligible to upgrade their child's car seat for \$15
- Caregiver must meet income guidelines
- A \$15 money order is required
- Caregiver must present ID when picking up car seat at either Leon or **Gadsden Service Center**

DOES YOUR CHILD NEED A CAR SEAT?

ELC Big Bend, in partnership with Kidsafe of Lutheran Social Services of North Florida, is able to provide new car seats for eligible Leon and Gadsden County families for just \$15.

Eligibility Requirements:



- Leon or Gadsden **County Resident**
- 🤝 Currently receiving School Readiness services or on the Waitlist

Your Car Seat Checklist:

- Receive School Readiness or currently on the Waitlist
- Bring a \$15 money order to your Leon or Gadsden Service Center
- Present ID when picking up your car seat
- The Safety Seat provided meets all safety standards and adapts to the growth requirements of a child from 5 to 100 pounds. Limit one car seat per child. Eligible families to pay \$15 via money order.
